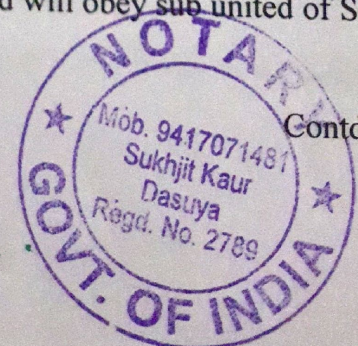
Above said Affiliation has given under following conditions:-

1. Approval for Affiliation is not extendable and it should not be considered that it is compulsory for approval of eight class next.
2. This school will obey the Act 2009 for children's free and compulsory education and obey the children's free and compulsory education Rules 2010 .
3. School will give admission 25% in 1<sup>st</sup> class to weaker section and non facilitative children, area around the school and will give free and compulsory Primary Education till its completion.
4. The expenses of children mentioned in Para 3 will be given to school under Act of section 12 of Sub Uniting Section( 2). School will kept separate bank account for its receipt.
5. Institution/ School will not charge any capitation fee and will not implement any method to choose children or their parents or their guardians.
6. School will not refuse to admit any child for not having birth proof and will obey sub united of Section 15. School will make sure that:-

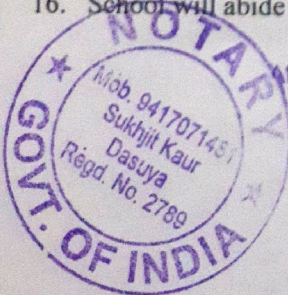

- (1) Any admitted child will not retain in back class or will not dismiss him till complete his Primary Education in the school.
  - (2) No Physical punishment or mental stress will be given to any child.
  - (3) No child is needed to pass any Board Exam till the completion of Primary Education.
  - (4) Certificate will be given to every child who has obtained Primary Education under given rule 25.
  - (5) Involvement of children with special needs under Sub United of Act.
  - (6) It is important for teachers to fulfill minimum educational eligibilities under Section 23(1) but next Condition is that existing teachers will obtain minimum educational qualification at the time of Imposed of this Act.
  - (7) The teachers will fulfill responsibilities given under Act of section 24( 1).
  - (8) The teachers will not indulge themselves in Private tuitions.
7. School will pursue the syllabus determined by appropriate authorities on the basis of subjects of education.
  8. No unauthorized class will take inside or outside the school building under the name of this school.
  9. School building or other structure or ground will only be used for education and competency development.
  10. The School is running under School Society Registration Act 1860(1860 of 21) register by society or is running under implementing law from time to time made by trust.
  11. School is not running for any personal organization or the organization of people or for the benefit of any other person.
  12. The Accounts should be audited by authorized Chartered Accountant and the statement of records will be prepared as per rules. The copy of each account table will be sent to District Education Officer (Elementary Education) every year.
  13. The affiliation code number of your school is RTE-569. It should be noted and while corresponding with this office, it should be entered.
  14. School will produce timely information asked by the District School Education Officer or higher Authorities or will obey the conditions of District Education Officer to fulfill the conditions of affiliation or to remove the short comings in the functioning of the school.
  15. Make sure the renewal of registration of the institution if necessary any due.
  16. School will abide by the determined conditions and standards given in section 19 of School Act.
